

UNIVERSITY OF GRONINGEN REGULATIONS FOR REGISTRATION AND TUITION FEES 2011-2012

The University of Groningen Regulations for Registration and Tuition Fees are based on Articles 7.32 to 7.50 of the Higher Education and Research Act (WHW: *Wet op het hoger onderwijs en wetenschappelijk onderzoek*) and contain the provisions governing registration at the University for academic year 2010-2012. The Regulations have been drawn up with due observance of the statutory provisions that apply on 1 September 2011.

SECTION 1:BACHELOR'S AND MASTER'S DEGREE PROGRAMMES

Chapter 1. GENERAL PROVISIONS

Article 1 Definitions

The following definitions apply to these Regulations:

- a. **The Act, WHW:** the Higher Education and Research Act (WHW; *Wet op het Hoger Onderwijs en Wetenschappelijk Onderzoek*)
- b. **Higher education:** education provided at universities (WO) and universities of applied sciences (HBO)
- c. **Minister:** the Minister of Education, Culture and Science
- d. **Institute:** the University of Groningen
- e. **Academic year:** a period of time that starts on 1 September and ends on 31 August of the following year
- f. **Degree programme:** a Bachelor's or Master's degree programme
- g. Student: a person who has paid tuition fees and is registered at the University of Groningen, with all the rights connected to his/her registration as set out in Article 7.34 WHW
- h. **External student (extraneus):** a person who has paid examination fees and is registered at the University of Groningen with all the rights connected to his/her registration as set out in WHW Art. 7.36
- h. **Statutory tuition fees:** the tuition fees as referred to in WHW Art. 7.45 for registration as a student, set by the Minister
- i. **University tuition fees:** the tuition fees as referred to in WHW Art. 7.46 for registration as a student, set by the Board of the University
- k. Examination fees: the examination fees as referred to in WHW Art. 7.44 for

- registration as an external student (extraneus), set by the Board of the University
- l. **Registration:** registration as effected upon submitting a request for registration and paying the relevant tuition fees or examination fees
- m. **Studielink:** national web application for registration at Dutch universities and universities of applied sciences
- n. **CRIHO:** the *Centraal Register Inschrijvingen Hoger Onderwijs* (Central Register for Registration in Higher Education), maintained by DUO (*Dienst Uitvoering Onderwijs*, the Dutch Education Executive Agency)
- o. UAF: University Assistance Fund for refugee students
- p. Wsf 2000: Wet studiefinanciering 2000 (Student Finance Act 2000)
- q. **GBA:** Municipal Personal Records Database
- r. BSA System: Binding (negative) Study Advice and the Study Advice System

Chapter 2. REGISTRATION

Article 2 Admission and admissibility

- 1. Students who have satisfied the entry requirements as set out in WHW Arts. 7.23a to 7.30 may be admitted to a Bachelor's degree programme at the University of Groningen.
- 2. Quotas (*numerus fixus*) apply to the following Bachelor's degree programmes in accordance with WHW Art. 7.53 or Art. 7.56:
 - a. Medicine
 - b. Dentistry
 - c. Business Administration
 - d. International Relations and International Organization
 - e. Life Science and Technology
 - f. Psychology.
- 3. In addition to the provisions of Articles 2.1 and 2.2, decentralized selection procedures in accordance with WHW Art. 7.57e apply to the Bachelor's degree programmes in Medicine and Dentistry.
- 4. Students who have satisfied the entry requirements as set out in WHW Arts. 7.30a to 7.30e may be admitted to a Master's degree programme at the University of Groningen.

Article 3 Registration

- 1. Registration as a student or external student (*extraneus*) at the University of Groningen is open to anyone who is over the age of eighteen and legally competent and can prove or who is under the age of eighteen and whose parents, guardians or carers can prove that he or she:
 - a. has Dutch nationality or is treated as a Dutch national on the basis of a legal provision
 - b. is a foreigner and younger than 18 years of age on the first day of the degree programme for which first-time registration is requested
 - c. is a foreigner, is over 18 years of age on the first day of the degree programme for which first-time registration is requested, and on that day is legally resident within the meaning of Article 8 of the Aliens Act 2000
 - d. is a foreigner and is living abroad on the first day of the degree programme for

- which first-time registration is requested
- e. is a foreigner who no longer satisfies one of the conditions listed under b, c or d, and who previously registered for a degree programme at the University of Groningen while satisfying one of those conditions, and who is still following that degree programme but has not yet completed it.
- 2. Registration as an external student *(extraneus)* can only take place if the Board of the University is of the opinion that this is not incompatible with the nature or the interests of the teaching in the chosen degree programme.
- 3. Requests for registration must be submitted via Studielink (www.rug.studielink.nl).

The following applies to a request for registration:

- a. applicants who have Dutch nationality, or who are treated as a Dutch national on the basis of a legal provision, must submit a copy of their passport or official identity card
- applicants who do not fall under a. must submit a copy of their passport or official identity card and proof that they possess a legally valid residence permit
- c. applicants must submit all documents that are requested.
- 4. Registration cannot take place until after a request to this end has been submitted in accordance with Article 3.3 and the relevant tuition or examination fees have been paid.
- 5. Registration is for the entire academic year. The request for registration must be submitted and payment of tuition or examination fees made before the start of the academic year, i.e. before 1 September 2011. At the student's request, registration in the month of September 2011 can be annulled as of 1 September 2011.
- 6. It is not possible to register with retroactive effect. In the event that registration is requested and/or tuition or examination fees are paid after the start of the academic year, registration will apply from the first day of the month in which the request was submitted. The tuition fees will be reduced by a twelfth part for each month that the applicant was not registered.
- 7. Each student or external student (*extraneus*) will receive a student card as proof of registration. A new copy must be applied for in the event that the student card is stolen; there may be a charge for this.
- 8. Registration after 1 February 2012 for academic year 2011-2012 is not possible for degree programmes to which a *numerus fixus* applies as of 1 September 2012.
- 9. Tuition fees or examination fees must be paid in accordance with the provisions set out in Chapter 4.

Article 4 BSA System

- 1. If a student is issued a binding (negative) study advice (BSA) for a degree programme, reregistration for that programme or for the cluster of related programmes to which that programme belongs is not possible for a period of 2 academic years starting on 1 September of the academic year immediately following, as set out in the BSA Manual 2010-2011.
- 2. The provisions of Article 4.1 shall continue to apply in full during any appeals procedure against a BSA.
- 3. A BSA issued by a different institute of higher education shall not affect registration at the University of Groningen.

Article 5 Refusal of registration (Judicium abeundi)

- 1. The Board of the University may in exceptional cases refuse or terminate a student's registration if this student's acts or statements prove him/her to be unsuitable for one or more of the professions which he/she is being trained for in his/her degree programme or for the practical preparation for the profession.
- 2. In the event that the board of an institute of higher education other than the University of Groningen has refused a student's registration for a degree programme in accordance with the provisions of Article 4.1, and the student requests registration in a similar or related degree programme offered by the University of Groningen, Article 4.1 shall also apply.
- 3. In the event that a student whose registration has been refused or terminated in accordance with the provisions of Articles 4.1 and/or 4.2 is registered for another degree programme that has specializations or other components similar or related to the degree programme for which registration has been refused or terminated, the Board of the University may decide to deny this student entry to the relevant specialization or other components of this degree programme.

Chapter 3. TUITION FEES AND EXAMINATION FEES

Article 6. Statutory tuition fees – general conditions

- The statutory tuition fees for registration for a full-time degree programme are €
 1,713.
- 2. The statutory tuition fees for registration for a part-time or dual degree programme are € 1,251.
- 3. The statutory tuition fees must be paid by students who:
 - a. when registering for a Bachelor's degree programme, have not previously gained a Bachelor's or Master's degree; when registering for a Master's degree programme, have not previously gained a Master's degree
 - b. reside in the Netherlands, Belgium, Luxembourg or one of the German states of North Rhine-Westphalia, Lower Saxony or Bremen, and
 - c. are members of one of the groups referred to in Article 2.2. of the Wsf 2000 or have Surinamese nationality (see Appendix 1).
- 4. Article 6.3.a does not apply to students who register for a degree programme in the medical or teaching fields for the first time.
- 5. An exception to the provisions of Article 6.3.a are students who:
 - a. are awarded a Bachelor's degree while at the same time being registered for a second Bachelor's degree programme, or
 - b. are awarded a Master's degree while at the same time being registered for a second Master's degree programme

for whom statutory tuition fees apply to the second degree programme for the remainder of the academic year.

Article 7. Statutory tuition fees – further conditions

- 1. The provisions of Article 6.3.a are based on the historical CRIHO file of 1 September 1991. Certificates gained before this date therefore do not qualify as previously gained degrees within the meaning of this article.
- 2. The provisions of Article 6.3.a assume that a student who is awarded a Master's degree has also already gained a Bachelor's degree.
- 3. Any final assessment in an integrated university degree programme successfully completed on or after 1 September 1991 is considered to be a previously gained Bachelor's and Master's degree.
- 4. Any final assessment in an integrated degree programme at a university of applied sciences successfully completed on or after 1 September 1991 is considered to be a previously gained Bachelor's degree.
- 5. The provisions of Article 6.3.b must be satisfied by the student by producing proof of registration in the GBA, if resident in the Netherlands, or by an extract from the relevant Municipal Personal Records Database, if resident in Belgium, Luxembourg or one of the German states listed above. The student must prove this by 30 September at the latest if registering from 1 September of an academic year.
- 6. A student who is registered at an institution of higher education and has paid the statutory tuition fees, and who in the same academic year also wishes to register for a degree programme at the University of Groningen to which statutory tuition fees apply, shall be exempt from payment of tuition fees for this second registration unless an amount lower than the statutory tuition fees has been paid for the first registration. In this case the student must pay the difference between the two amounts. A BBC statement (*Bewijs betaald collegegeld*, proof of payment of tuition fees) with regard to the first registration must be submitted with the request for registration.
- 7. If at any time during the academic year a student no longer satisfies the conditions for statutory tuition fees, he or she must pay University tuition fees for the remainder of the academic year.

Article 8. University tuition fees I

- 1. University tuition fees I for registration for a full-time degree programme are € 1,713.
- 2. University tuition fees I for registration for a part-time or dual degree programme are € 1,251.
- 3. University tuition fees I must be paid by students within the meaning of Article 6.5 who reregister for a second degree programme in a new academic year. Such students may continue with the second degree programme until academic year 2012-2013 for University tuition fees I on condition that their registration for the second degree programme since gaining the first degree has been uninterrupted.
- 4. University tuition fees I must be paid by students who satisfy the residence requirement and the nationality requirement of Articles 6.3.b and 6.3.c, and who are registered for a bridging programme with a student workload of a maximum of 60 ECTS credit points, whereby registration for a Bachelor's degree programme takes place but no Bachelor's degree is awarded.
- 5. The provisions of Article 8.4 also apply to the 78 ECTS HBO-Law bridging programme offered by the Faculty of Law, which prepares students for the

- Master's degree programme in Dutch Law for admission to the legal professions or judiciary (*civiel effect*).
- 6. The provisions of Article 8.4 also apply to the 71 ECTS Accountancy and Controlling Pre-Master's bridging programme offered by the Faculty of Economics and Business, which prepares students for admission to the Master's degree programme in Accountancy and Controlling.
- 7. University tuition fees I must be paid by students who have been recognized by the UAF as student refugees.
- 8. University tuition fees I must be paid by all students participating in an Erasmus Mundus degree programme at the University of Groningen and who are recognized by the faculty in question as such, and who do not satisfy the conditions for statutory tuition fees.
- 9. Article 7.6 does not apply to University tuition fees. With multiple registrations, the sum of the required tuition fees must be paid.

Article 9. University tuition fees II

- University tuition fees II for registration as a student in a full-time Bachelor's degree programme are € 6,900, € 9,400 or € 32,000 respectively (see Appendix 2).
- 2. University tuition fees II for registration as a student for a part-time or dual Bachelor's degree programme are € 3,844.
- 3. University tuition fees II for registration for a full-time Master's degree programme are € 7,900, € 9,600, € 11,400 or € 32,000 respectively (see Appendix 2).
- 4. University tuition fees II for the Master's degree programme in Education and Communication in Mathematics and Natural Sciences are € 2,620.
- 5. University tuition fees II for registration as a student in a part-time or dual Master's degree programme are € 4,349, except for a part-time or dual Master's degree programme at the Faculty of Law, which is € 5,209.
- 6. University tuition fees II must be paid by all students who do not satisfy the requirements for eligibility for statutory tuition fees or University tuition fees I.
- 7. The provisions of Articles 9.1-6 concerning tuition fees may be overruled if the Board of the University makes special arrangements with a university abroad.
- 8. Article 7.6 does not apply to University tuition fees. With multiple registrations, the sum of the required tuition fees must be paid.

Article 10 Transitional arrangements

- 1. Students registered at the University of Groningen in academic year 2010-2011 and who qualified for tuition fees in that year of € 1,672 (full time) or € 1,237 (part-time/dual) on the basis of the transitional regulations qualify for university tuition fees that are the same as the statutory tuition fees on reregistration for academic year 2011-2012 for the same degree programme as they were registered for in August 2011. The degree programme can thus be continued for University tuition fees I, on condition that the registration is not interrupted.
- 2. Students who followed the bridging programme for the Master's degree programme in Medicine in academic year 2010-2011 and registered for the Master's degree programme in Medicine from 1 September 2011, and who have already gained a Master's degree in Health Care within the meaning of Articles

- 6.3.a and 6.4, qualify for University tuition fees that are the same as the statutory tuition fees on condition that they satisfy the nationality and residence requirements set out in Articles 6.3.b and 6.3.c.
- 3. Students who already have a Master's degree and in academic years 2009-2010 and 2010-2011 were registered for:
 - a) a Pre-Master's bridging programme at the Stichting voor Pedagogisch Onderwijs (SPO), or
 - b) a Pre-Master's bridging programme in Psychology or Sociology at the University of Groningen, registered as a contract student at the University of Groningen,

and who register in academic year 2011-2012 as students of the relevant Master's programme at the Faculty of Behavioural and Social Sciences, will be considered the equivalent of a University of Groningen student within the meaning of the provisions of Article 10.1, so that they qualify for University tuition fees that are the same as the statutory tuition fees.

4. Students who:

- a. have been allocated a place on the Oral Surgery degree programme by the Oral Surgery Department of the UMCG, and
- b. have successfully completed the Bachelor's and Master's degree programmes in Dentistry or the Bachelor's and Master's degree programmes in Medicine, and
- c. within the framework of their oral surgery training programme must also complete the Bachelor's and Master's degree programmes in either Dentistry or Medicine (depending on the programmes they have already completed, see Article 10.4.b), and
- d. started this second Bachelor's or Master's degree programme in Health Care in academic year 2010-2011 (2010-2011 cohort),

must pay University tuition fees I when reregistering for the other Bachelor's and Master's degree programmes, on condition that the requirements of nationality and place of residence as referred to in Articles 6.3.b and 6.3.c are satisfied.

Article 11. Examination fees

- 1. Those who wish to register as an external student (*extraneus*) for a Bachelor's or Master's degree programme and meet the conditions for statutory tuition fees or University tuition fees I must pay examination fees of € 1,713.
- 2. Those who wish to register for a Bachelor's degree programme as an external student (*extraneus*) and do not meet the conditions for statutory tuition fees or University tuition fees I must pay examination fees of € 6,900, € 9,400 or € 32,000 respectively.
- 3. Those who wish to register for a Master's degree programme as an external student (*extraneus*) and do not meet the conditions for statutory tuition fees or University tuition fees I must pay examination fees of € 7,900, € 9,600, € 11,400 or € 32,000 respectively.
- 4. The examination fees are due in full, regardless of the moment of registration in the academic year.

Article 12 Damages

- 1. Article 15.2 WHW states that anyone who uses teaching or examination facilities without legally valid registration is liable for damages.
- 2. These damages amount to one-twelfth of the relevant tuition fees for each month in which the person in question has illegally used the teaching and examination facilities of a University of Groningen degree programme.
- 3. The damages will be charged in addition to the relevant tuition fees payable for the entire academic year.
- 4. Registration will take place as of the first day of the month in which payment as referred to in Article 12.3 is made. It is not possible to register with retroactive effect.
- 5. Those who wish to receive a degree certificate but who have used teaching or examination facilities without legally valid registration may make a statement to the Board of the University that the procedural requirements for awarding the degree certificate have been satisfied upon payment of the amounts referred to in Article 12.3. The examinations sat by the student in order to gain the degree certificate will thus become valid.

Chapter 4. PAYMENT

Article 13. Payment of tuition fees and examination fees

- 1. Tuition fees and examination fees may be paid:
 - a. in full (in one instalment), or
 - b. in several instalments.
- 2. Payment must be made via a direct debit mandate, via a transfer to the University of Groningen account, via a PIN payment at the University Student Desk in the Academy Building, or by cash at the Cashier's Office in the Academy Building.

Article 14. Payment in instalments

- 1. If the tuition fees are paid in instalments, a direct debit mandate must be issued to the University of Groningen.
- 2. The tuition or examination fees will then be debited in 5 equal instalments, spread over the academic year.
- 3. A non-recurring administration fee of € 24 will be charged for payment in instalments. This amount will be debited together with the first instalment.
- 4. In the event that an instalment cannot be debited, a term will be set within which the instalment must be paid.
- 5. If an instalment cannot be debited, the student in question will be excluded from the University facilities (including IT facilities) after having been informed of the situation.
- 6. If an instalment cannot be debited and the student has not arranged alternative payment of this instalment in advance, all remaining tuition fees will fall due in one instalment once the student has officially been served notice of default. Payments of tuition fees shall be credited to the longest outstanding instalment.
- 7. All collection charges shall be borne by the student.
- 8. If one or more instalments are paid late during an academic year, the student in question may not pay in instalments the next academic year.

9. In the event that the tuition fees have not been paid in full by the end of an academic year (31 August), the student in question will not be able to register for the next academic year until the outstanding amount has been paid.

<u>Chapter 5. DEREGISTRATION AND REIMBURSEMENT OF TUITION</u> FEES

Article 15. Deregistration on request

- 1. A request to deregister must be submitted before the end of the academic year. Requests received after this date will not be processed.
- 2. Requests to deregister must be submitted via Studielink.
- 3. Deregistration will take effect on the first day of the month after a request to this end is submitted.
- 4. A request to deregister due to graduation will come into force in the month following the month of the examination date, on condition that it is in the same academic year.

Article 16. Deregistration for other reasons

- 1. In the event of death, deregistration will take effect on the first day of the month after the month in which the student died.
- 2. In the event of payment arrears, if an instalment cannot be debited within the term stipulated in Article 14.4, registration may be terminated on the first day of the second month after this term has ended.
- 3. If the Board of the University decides that a student has proved unsuitable, as set out in Article 5, this student's registration will be terminated on the first day of the month following the month in which this decision was taken.
- 4. In the event that the Board of the University decides to terminate a student's registration on the grounds of contravention of the University of Groningen House Rules and General Code of Conduct or on the grounds of fraud, deregistration will take effect on the first day of the month following the month in which this decision was taken.
- 5. Deregistration within the meaning of Articles 16.2, 16.3 and 16.4 will not take place until the relevant student has been informed.

Article 17. Reimbursement

- 1. Tuition fees are only reimbursed upon termination of registration.
- 2. Upon deregistration, one-twelfth of the statutory or University tuition fees that apply to the registration in question will be reimbursed for each remaining month in the academic year. With deregistration as of 1 July, no tuition fees will be reimbursed for the months of July and August, except in a situation within the meaning of Article 16.1.
- 3. External students (extraneus) are not entitled to reimbursement of examination fees.

SECTION 2: PHD PROGRAMMES

Chapter 1. GENERAL PROVISIONS

Art. 1. Definitions

- a. **Tuition fees:** the tuition fees to be paid for registration as a PhD student
- b. **Registration**: registration as a PhD student with the graduate school and payment of the relevant tuition fees (unless a PhD student is fully or partly exempt from paying tuition fees)
- c. **Academic year:** a period of time that starts on 1 September and ends on 31 August of the following year
- d. **PhD student:** a student who is selected for a PhD programme offered by a graduate school
- e. **Scholarship PhD student (***bursaal***):** a non-Dutch PhD student on a scholarship
- f. **Graduate school:** the school which organizes the PhD programme
- g. **PhD programme:** a training programme that prepares students for gaining a PhD
- h. **Ubbo Emmius contract:** a contract setting out the agreements made between a scholarship PhD student and the University of Groningen concerning the PhD programme.

Chapter 2. REGISTRATION

Art. 2. Registration procedure for PhD programmes

- 1. Registration as a PhD student is open to those covered by the provisions of Article 3.1 of Section 1 of these Regulations.
- 2. Registration for a PhD programme is in principle for the entire academic year. If registration takes place during the academic year, it will apply for the remainder of that academic year.
- 3. The following documents must be submitted for registration:
 - a. A person with Dutch nationality, or who is treated as a Dutch national on the basis of a legal provision, must submit a copy of his or her passport or official identity card, or an extract from the Municipal Personal Records Database (GBA).
 - b. People who do not fall under a. must submit an extract from the Municipal Personal Records Database (GBA) and proof that they possess a legally valid residence permit.
- 4. In the event of registration after the start of the academic year, the tuition fees will be reduced by one-twelfth for each month in which the student in question was not registered.

Art. 3. Deregistration procedure

- 1. A written request to deregister must be submitted before the end of the academic year. Requests received after this date will not be processed.
- 2. The University of Groningen may terminate a PhD or scholarship PhD student's

registration as stipulated in the Regulations of the PhD Programme or in the Ubbo Emmius contract.

Chapter 3. TUITION FEES

Art. 4. Amounts

- 1. PhD students/scholarship PhD students must pay University tuition fees of € 7,900, € 9,600 or € 11,400.
- 2. <u>Appendix 3</u> lists the tuition fees for the various degree programmes.

Art. 5. Reduction of and exemption from tuition fees

- 1. Dutch scholarship PhD students on a University of Groningen scholarship are exempt from payment of tuition fees for the PhD programme.
- 2. Non-Dutch scholarship PhD students on a University of Groningen scholarship are exempt from payment of tuition fees for the PhD programme.
- 3. Other scholarship PhD students may be partly or wholly exempted from payment of tuition fees for the PhD programme by the Board of the University.

Art. 6. Reimbursement procedure

- 1. Reimbursement of tuition fees is only possible after the PhD is awarded. A request for reimbursement must be submitted at the same time as the request for deregistration.
- 2. The request for reimbursement must be submitted before the end of the academic year.
- 3. One-twelfth of the tuition fees paid will be reimbursed for each month remaining in the academic year, starting in the month following the month in which the PhD was awarded.
- 4. No tuition fees will be reimbursed if the University of Groningen terminates a PhD student's registration.

These regulations only apply to academic year 2011-2012. New rates or rules may apply in future academic years.

Appendix 1:

Explanatory notes to Article 6.2.c of Section 1 of these Regulations

Who is covered by the groups referred to in Article 2.2 of the *Student Finance Act 2000*?

The following individuals are covered by these groups:

- a) People with Dutch nationality
- b) Nationals of one of the EU member states: Austria, Belgium, Bulgaria, Cyprus, the Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Poland, Portugal, Romania, Slovenia, Slovakia, Spain, Sweden and the United Kingdom
- c) Nationals of an EEA country that is not an EU member state: Iceland, Liechtenstein and Norway
- d) Under special conditions, people with Turkish nationality based on Association Decision 1/80 of the Association Council EEC/Turkey (children of workers who live in an EU member state where they work or have worked)
- e) People with Swiss nationality (since 1 June 2002 on the basis of the treaty of 21 June 1999, enacted on 14 September 2001, *Staatsblad* 432)
- f) Family members (spouse; partner with whom a citizen of the European Union has registered a partnership in accordance with the legislation of that country, in so far as the legislation of the host country equates partnership with marriage and if the conditions of the host country's legislation are satisfied; blood relatives in the direct descending line as well as those of the spouse or partner younger than 21 years of age or who are dependent on them; blood relatives in the direct ascending line as well as those of the spouse or partner who are dependent on them) of EU citizens resident in the Netherlands who do not have EEA nationality (based on Directive 2004/38/EG)
- g) Foreigners who are only legally resident on the basis of a residence permit for asylum seekers for a fixed period (Article 28 of the Aliens Act)
- h) Foreigners who are only legally resident on the basis of a residence permit for asylum seekers for an indefinite period (Article 33 of the Aliens Act)
- i) Foreigners who are only legally resident on the basis of a regular residence permit for an indefinite period (Article 20 of the Aliens Act 2000) (this includes long-term resident third-country nationals (based on Guideline 2003/109/EC))
- j) Foreigners who are only legally resident on the basis of a regular residence permit for a fixed period (Article 14 of the Aliens Act 2000). Such permits must have been issued under one or more of the following conditions: 1°. family reunification or family formation as referred to in Article 15 of the Aliens Act 2000 with a Dutch national or with a foreigner as referred to in Article 3.1.a or b of the Student Finance Decree 2000 or an extended stay due to one of these reasons
 - 2°. residence as an unaccompanied foreign minor or an extended stay due to this reason
 - 3°. residence with the aim of adoption or fostering, or a stay due to this reason

- 4°. litigation related to human trafficking or an extended stay due to this reason
- 5°. residence as an alien who through no fault of his/her own is unable to leave the Netherlands, or an extended stay due to this reason
- 6°. residence other than that listed in Article 3.4.1 of the Aliens Decree 2000 but within the meaning of Article 3.4.3 of the Aliens Decree 2000, or an extended stay due to this reason
- 7°. residence related to the legacy of the previous Aliens Act as referred to in Article 3.17.a part b of the Aliens Regulations 2000, or an extended stay due to this reason
- k) Foreigners waiting for a decision on their request for a residence permit or an extension of a residence permit, in so far as they already receive Student Finance (Article 3.e, Student Finance Decree 2000)
- l) Foreigners who have previously received an allowance (under the WTOS) (Article 3.f, Student Finance Decree 2000).
