

#### **Preamble**

These regulations are valid for both the English and the Dutch tracks of the MSc-programme, as specified by/in Studielink. For specific Dutch courses or tracks the Dutch language will be used.



# 1 Aim of the programme and language of the courses

#### 1.1 Aim of the degree programme

The aim of the programme is to give the student:

- Specialised scientific knowledge, skills, and understanding of psychology;
- Preparation for a career as a professional, academically trained psychologist;
- Preparation for subsequent training as a researcher in the area of psychology.

#### 1.2 Language

Most programme courses and exams are offered in the English language. In this text, all courses with English names are taught in English, and all courses with Dutch names are taught in Dutch. In courses taught in the English language, a student may formulate answers in Dutch in case of assignments and an essay exam, as far as the language proficiency of the lecturer(s) allows. Likewise, the Master thesis can be written in Dutch, as far as the language proficiency of the lecturer(s) allows. For Clinical Psychology and Clinical Neuropsychology, students enrol for either the Dutch or the English programme and can only take exams in the programme of choice accordingly.



# 2 The degree programme

#### 2.1 Specialisation tracks

The programme contains the tracks (sometimes denoted as "sub-programmes") listed below. A student can only graduate in one track, and therefore only participate in one track.

- a. The track *Applied Social Psychology*, which prepares for a career as a psychologist and the conducting research in the field of Social Psychology
- b. The track *Clinical Psychology*, which prepares for a career as a psychologist and the conducting research in the field of Clinical Psychology; there are no new enrolments in 2023, and this track will be discontinued per September 2024
- c. De track *Klinische Psychologie*, die voorbereidt op de beroepsuitoefening als psycholoog en op het verrichten van onderzoek op het gebied van de klinische psychologie;
- d. The track Clinical Forensic Psychology & Victimology, which prepares for a career as a psychologist and conducting research in the field of Clinical Forensic Psychology & Victimology
- e. De track *Klinische Neuropsychologie*, die voorbereidt op de beroepsuitoefening als psycholoog en op het verrichten van onderzoek op het gebied van de neuropsychologie;
- f. The track *Clinical Neuropsychology*, which prepares for a career as a psychologist and conducting research in the field of Clinical Neuro-psychology
- g. De track *Ontwikkelingspsychologie*, die voorbereidt op de beroeps- uitoefening als psycholoog en op het verrichten van onderzoek op het gebied van de ontwikkelingspsychologie;
- h. The track *Applied Cognitive Neuroscience*, which prepares for a career as a psychologist and conducting research in the field of Applied Cognitive Neuroscience
- The track Environmental Psychology which prepares for a career as a psychologist and conducting research in the field of Environmental Psychology
- j. The track *Theory and History of Psychology*, which prepares for a career as a psychologist and conducting research in the field of Theory and History of Psychology.
- k. The track Talent Development and Creativity, which prepares for a career as a psychologist and conducting research in the field of Talent Development and Creativity
- The track Work, Organizational and Personnel Psychology, which prepares for a career as a psychologist and conducting research in the field of Work, Organisation and Personnel Psychology


#### 2.2 Structure of the programme

1. Each track in Article 2.1 contains the following compulsory modules with a study load as indicated

1.	Foundation courses	10 EC
2.	Skills courses	5 EC
3.	Methodology courses	5 EC
4.	Elective courses	10 EC
5.	Internship	10 or 20 EC*
6	Master Thesis	10 or 20 EC*

<sup>\*</sup> Not every combination of internship and thesis is possible for each track. Specific details on the possibilities for each individual track are described in articles 2.7 and 2.8.

- 2. Courses listed in the 2022-2023 OER that will no longer be offered in 2023-2024 will only be offered once as exams in 2023-2024.
- 3. One Internship and one Master Thesis always must add up to 30 EC.
- 4. Students can enrol for a maximum of four courses per block.
- 5. Students can enrol for a maximum of two Capita Selecta courses.
- 6. Students who started before the 1st of September of the current academic year:
   are allowed to complete courses they took in the previous academic year but did not yet pass (i.e., get exam opportunities, cf. the relevant article about deleted courses of the GWM-OER). This is valid only for the current academic year;




- are allowed to have their courses approved for graduation according to the status of that course as described in article 2 and its subsections in the Psychology-Master-OER of the previous academic year;
- have to re-plan their possibilities for a deleted course that they did not yet take in the previous academic year.







- 2. For the courses to which Article 2.9.1 refers, the examination cannot be registered in ProgressPortaal before the successful completion of the practical. Where a practical consists of clearly separated modules, these separate modules stay valid for the period of the current and the next academic year.
- 3. For the following courses the successful completion of the practicum is considered equivalent to passing the examination: the Master Thesis; the Master Internship; all skills courses.






# 3 Examinations of the programme

#### 3.1 Mandatory order

For the following courses you cannot take the exam, before the courses mentioned with it are being followed or have been passed:

- For the *Ontwikkelingspsychologie* track: the Master Internship can only be started having passed MOV-1
- For the *Clinical Neuropsychology* and *Klinische neuropsychologie* tracks: the Master Internship can only be started after having passed MNV-2
- For the Talent Development and creativity track: the Master Internship can only be started when following or having passed MOB-7. For the *Clinical Psychology* and *Klinische psychologie* tracks: the Master Internship can only be started after having passed MKV-1 or MKV-3
- For the *Clinical Forensic Psychology & Victimology* track: MFB-2 Crime & psychological assessment and interventions and MFV-1 Clinical Forensic Skills can only be taken after MFB-1 Crime & psychological vulnerability is being followed or has been passed.
- For the *Clinical Forensic Psychology & Victimology* track: MFV-1 Clinical Forensic Skills can only be followed when MFB-2 Crime & psychological assessment is being followed simultaneously
- For the *Clinical Forensic Psychology & Victimology* track: the Master Internship can only be taken after having passed MFV-1



### 4 Admission

#### 4.1 Admission criteria

For admission criteria, the Master's programme distinguished general criteria and criteria specific to each track. A completed bachelor in Psychology at a Dutch research University will by default be considered to satisfy the general criteria. In addition to the general criteria, all applicants should satisfy the criteria specific to each respective track.


- a. General criteria
- Bachelor Diploma of a Research University\*;
- English language requirements (see 4.5);
- At least 60 EC or 65 EC (for all Clinical tracks) covering substantive psychology courses; in some cases partial compensation is possible, see website.
- At least 15 EC covering statistics, in which you were at least taught on the following topics (in reasonable depth):
  - Basic descriptive statistical techniques,
  - Basic graphical statistical techniques,
  - Basic inferential statistical techniques (confidence intervals, significance testing),
  - Nonparametric statistic,
  - Simple and Multiple regression,
  - Logistic regression,
  - ANOVA (One- and Two way designs),
  - Repeated measures ANOVA,
  - ANCOVA,
  - Moderator analysis (= regression analysis including interactions of quantitative predictors).

For the track Theory and History of Psychology partial compensation is possible, see website.

- At least 10 EC covering psychological research methodology:
  This should include theoretical concepts in research methodology (5 EC) and research
  ethics, as well as practical training (5 EC) in carrying out a full research project (i.e.,
  deriving and formulating a research question, designing a study (which should be at least
  partially quantitative), collecting data, analyzing results, reporting the whole project,
  finishing with a discussion and conclusion section):
- At least 5 EC covering the study of reliability and validity of psychological tests. (discussing at least classical test theory);
- At least 5 EC covering theory/philosophy of science and/or history of psychology.
- \* In special cases, when applicants hold a diploma in Toegepaste Psychologie on an HBO level, admission with a supplementary programme is possible

- d. Specific criteria for **Ontwikkelingspsychologie**
- Out of 60 EC in Bachelor courses covering substantive psychology, at least 10 EC in the field of Developmental Psychology, comparable to the University of Groningen courses Ontwikkelingspsychologie (5 EC), Persoonlijke documenten en de constructie van de levensloop (5 EC), Interventions in individual development (5 EC), Theorieën over ontwikkelingsgebieden (5 EC), Diagnostiek in de ontwikkelingspsychologische praktijk (5 EC) and Ontwikkeling, opvoeding en onderwijs (5 EC).
- At least 5 EC on communication and diagnostic skills. Comparable to the University of Groningen course Communication and Diagnostic Skills (5 EC);
- e. Specific criteria for Environmental Psychology
- Admission to the Environmental Psychology track is also possible as part of the Double Degree Programme in Sustainability and Environmental Psychology that exists between the Psychology Programme at the University of Groningen and Leuphana University of Lüneburg, Germany.

#### 4.2 Premasters

- 1. Some applicants who do not meet criteria under 4.1, have the possibility to follow a premaster programme:
  - a. Applicants with a degree in HBO Toegepaste Psychologie, who have obtained at least 20 EC in psychology courses at university level and have proficiency in Statistics at a university propaedeutical Bachelor Psychology level, are eligible to follow a premaster programme for all tracks.
  - b. Applicants with a Dutch non-Psychology Bachelor's degree (with a maximum of 60 EC deficiency in comparison to the admission criteria for the Master) are eligible to follow a premaster programme only for the following tracks:
  - Applied Cognitive Neuroscience;
  - Theory and History of Psychology;
  - Applied Social Psychology;
  - Environmental Psychology;
  - Talent Development and Creativity;
  - Ontwikkelingspsychologie
  - Work and Organizational psychology
- 2. Pre-Master's programmes have a maximum workload of 60 EC and must be completed within two academic years. They are determined individually by the Admissions Board.

Capacity for the premaster is limited for each track:

Allocation takes place by drawing lots. Registration is possible for a maximum of two tracks. For each track, a draw will first take place among the students who indicated a track as their first choice. If after the first draw not all places are filled, a draw will take place among the students who indicated these respective programmes as their second choice.

- 3. Upon successful completion of a premaster programme within two years after starting in September 2021 or later, the student will be admitted to the track associated with the completed premaster. For students who started the premaster before September 2021, different regulations hold, as described in their letters of admission to the premaster.
- 4. If a student does not finish the premaster, and for whatever reason will stop being enrolled, then the student will have no right to get re-enrolled in the premaster within the next five years.

#### 4.3 Selection / limited number of student places

- For admission to the master programme in September 2021 and later, students who are found admissible will enter a selection procedure for the track of their choice. The outcome of this procedure will determine whether or not they will be granted access to the track of their choice.
- Capacity is limited in the Master's tracks. The capacity per track is as follows:

The Admissions Board reserves the right to admit a few more students than the available places to compensate for potential withdrawals.

#### 4.4 Selection procedure and deadline for registration

1. Selection for the programme and admission to the respective programmes falls under the responsibility of the Faculty Board, which has set up a mandated admissions board. A study adviser or policy officer may act as an advisory member of the board.

#### 2. Selection is based on:

- a. A selection test which will examine knowledge of subjects that are expected to be covered in general Psychology Bachelor's programmes. The test will be administered around 1 May (for the starting date in September) and around 10 November (for the starting date in February). Details can be found in the test regulations. Please note that, if for a track there are more places than candidates, then a selection test will not be administered to those candidates.
- A motivation letter. A screening for pass/fail will take place, whereby fail only applies
  to letters where the text clearly does not describe a possible motivation for choosing



the track at hand. Letters of motivation will be assessed by the admission board.

- 3. Based on the results of the selection test, for each track a list will be generated of the order in which students will be allocated to that track. Details can be found in the test regulations. Because the test will have to be taken online, the procedure for determining the ranking of students has been adjusted by the faculty board into: first categorizing scores in High/Low and using a lottery to rank students in category High, and appending to this ranking a ranking based on a lottery for students in category Low.
- 4. a. Candidates submit a request via Studielink for admission to the degree programme. They then register for up to two tracks via the study programme's website. They indicate which track is their first choice and which is their second choice. It is not allowed to choose as first and second choice, two tracks the names of which are literal translations of each other.
  - b. Deadlines for the above procedures are March 1 and October 1, respectively, for programmes starting September 1 and February 1.
- 5. The student is admitted to a specific track by the admission board. Transferring to another track is not possible.
- 6. Admission is granted on the condition that, no later than the relevant starting date, the candidate shall fulfil the requirements of Article B.4.1 concerning knowledge and skills, as indicated on the certificates that the student has obtained for completed study programmes. On the written reaction to the request for admission the possibility of appeal to the Board of Appeals will be mentioned.

#### 4.5 Language

Students should be able to show that they have sufficient knowledge of the language of the particular track.

- 1. For English tracks this means that the following qualifications are accepted as sufficient proof of mastery:
  - a. Dutch VWO-level English proficiency
  - b. internet based TOEFL test outcomes greater than or equal to 90 (overall), 21 (speaking) and 24 (writing);
  - c. IELTS test outcomes greater than or equal to 6.5 (overall), 6.5 (speaking) and 6.5 (writing):
  - d. Cambridge C1 Advanced test with A, B or C (meaning sufficient score on this test);
  - e. Cambridge C2 Proficiency test with A, B or C (meaning sufficient score on this test);
  - f. University of Groningen Language Center Test/CEF B2 speaking and C1 writing;
  - g. English as a first language;
- 2. For the Dutch tracks Ontwikkelingspsychologie, Klinische Psychologie and Klinische Neuropsychologie this means that the following qualifications are accepted as sufficient proof of mastery:
  - a. Proof of proficiency in Dutch at native language level.
  - b. Diploma of a Dutch-language secondary school
